

Through Ministerial Agreement No. 388, dated December 6, 2014, the Minister of the Environment, Lorena Tapia Nuñez, Esq., delegates the functions of the Minister of State to Lorena Priscila Sanchez Rugel, from December 6-16, 2014;

In application of the authorities established in Numeral 1 of Article 154 of the Constitution of the Republic of Ecuador, in concordance with Article 17 of the Legal Administrative Regimen Statute of the Executive Branch;

RESOLVES TO:

- Art. 1.** Reform the Title of Environmental License No. 1917, dated November 29, 2012, granted to Consorcio DGC, for the execution of the project: *“Development and Production of the Singue Field, for the Singue-1 Pad and Expansion of the Access Road, located in the province of Sucumbios, counties of Putumayo and Lago Agrio, parishes of Pacayacu and Palma Roja”* to the company GENTE OIL ECUADOR PTE. LTD.
- Art. 2.** The company, GENTE OIL ECUADOR PTE. LTD. will strictly comply with the approved Environmental Impact Assessment and Environmental Management Plan, and other obligations set forth in Ministerial Resolution No. 1917, dated November 29, 2012, for which the Environmental License was granted for the execution of the project: *“Development and Production of the Singue Field, for the Singue-1 Pad and Expansion of the Access Road, located in the province of Sucumbios, counties of Putumayo and Lago Agrio”*.
- Art. 3.** The company, GENTE OIL ECUADOR PTE. LTD. will maintain the performance bond for the Environmental Management Plan in effect during the duration of the project.
- Art. 4.** Approve the *“Scope to the Environmental Impact Assessment and the Development and Production Phase of the Singue Block, Expansion of the Access Road and Singue-1 Pad for the drilling of 3 injector wells,”* located in the province of Sucumbios, counties of Lago Agrio/Putumayo, parishes of Pacayacu/Palma Roja, based on Document No. MAE-SCA-2014-3214, dated December 8, 2014, based on the pronouncement of the National Forestry Office, issued with Memorandum No. MAE-DNF-2014-3477, dated November 17, 2014, and Technical Report No. 742-14-ULA-DNPCA-SCA-MA, dated December 5, 2014, issued through Memorandum No. MAE-DNPCA-2014-2400, dated December 8, 2014, and in accordance with the coordinates established in the Intersection Certificate issued through Document No. MAE-DNPCA-2014-1172, dated August 7, 2014.
- Art. 5.** Declare the project *“Development and Production Phase, Expansion of the Access Road and Singue-1 Pad for the drilling of 3 injector wells”* located in the province of Sucumbios as an integral part of Resolution No. 1917, dated November 29, 2012, through which the Environmental License is granted for the Project: *“Development and Production of the Singue Field, for the Singue-1 Pad and Expansion of the Access Road, located in the province of Sucumbios, counties of Putumayo and Lago Agrio”*.
- Art. 6.** A fixed term of 30 days is granted to GENTE OIL ECUADOR PTE. LTD. to comply with the obligations established in Environmental License No. 1917, dated November 29, 2012, as set forth in Memorandum No. MAE-DNCA-2014-4056, dated December 3, 2014, of the National Environmental Control Office of the Ministry of the Environment, which attaches the Report of Coordinates of the Environmental Licenses – SINGUE BLOCK.
- Art. 7.** The supporting documents that were presented to back the environmental evaluation of the project will become an integral part of the *“Scope to the Environmental Impact Assessment and the Development and Production Phase of the Singue Block, Expansion of the Access Road and Singue-1 Pad for the drilling of 3 injector wells,”* located in the province of Sucumbios, which must strictly be complied with. On the contrary, the Environmental License will be suspended or revoked, according to what is established in Article 68 and Article 69 of Ministerial Agreement No. 074, published in Official Gazette No. 063, dated August 21, 2013.

The Legal Representative of GENTE OIL ECUADOR PTE. LTD. is hereby notified of this Resolution, and it is thus published in the Official Gazette as it is of public interest.

The Under Secretariat of Environmental Quality and the Provincial Office of the Ministry of the Environment in Sucumbios are responsible for ensuring application of this Resolution.
