RESOLVES TO:

- Art. 1. Approve the "SCOPE TO THE ENVIRONMENTAL IMPACT ASSESSMENT AND ENVIRONMENTAL MANAGEMENT PLAN FOR THE DEVELOPMENT AND PRODUCTION PHASE FOR THE DRILLING AND/OR WORKOVER OF 8 DEVELOPMENT WELLS IN THE SINGUE B PAD AND THE SINGUE C PAD, AND THE INSTALLATION OF THE FLOWLINE FROM SINGUE B, IN THE SINGUE BLOCK, FOR THE SECOND EXPANSION OF THE SINGUE B PAD, DRILLING OF 20 WELLS, CONSTRUCTION OF THE ACCESS ROAD AND INSTALLATION OF THE FLOWLINE, located in the province of Sucumbios, based on Document No. DNPCA-SCA-MA-2015-00401, dated August 28, 2015, Documents MAE-SUIA-DNF-2015-00043, dated August 18, 2015 and MAE-SUIA-DNF-2015-00044, dated August 20, 2015 issued by the National Forestry Office, and Technical Report No. 77-15-ULA-DNPCA-SCA-MA, dated August 28, 2015, and in accordance with the coordinates established in the Intersection Certificate issued through Document No. MAE-SUIA-RA-DNPCA-2015-20904, dated March 11, 2015.
- Art. 2. Declare the "SCOPE TO THE ENVIRONMENTAL IMPACT ASSESSMENT AND ENVIRONMENTAL MANAGEMENT PLAN FOR THE DEVELOPMENT AND PRODUCTION PHASE FOR THE DRILLING AND/OR WORKOVER OF 8 DEVELOPMENT WELLS IN THE SINGUE B PAD AND THE SINGUE C PAD, AND THE INSTALLATION OF THE FLOWLINE FROM SINGUE B, IN THE SINGUE BLOCK, FOR THE SECOND EXPANSION OF THE SINGUE B PAD, DRILLING OF 20 WELLS, CONSTRUCTION OF THE ACCESS ROAD AND INSTALLATION OF THE FLOWLINE, located in the province of Sucumbios as an integral part of the Environmental License issued through Resolution No. 237, dated April 25, 2014, to the company, GENTE OIL ECUADOR PTE. LTD. for the Development and Production Phase of the Singue B Pads for the drilling of 8 development wells and the installation of the flowline and Singue C for the drilling of 8 development wells of the Singue Block, located in the province of Sucumbios.
- Art. 3. The supporting documents that were presented with the environmental evaluation of the project will become an integral part of the project "SCOPE TO THE ENVIRONMENTAL IMPACT ASSESSMENT AND ENVIRONMENTAL MANAGEMENT PLAN FOR THE DEVELOPMENT AND PRODUCTION PHASE FOR THE DRILLING AND/OR WORKOVER OF 8 DEVELOPMENT WELLS IN THE SINGUE B PAD AND THE SINGUE C PAD, AND THE INSTALLATION OF THE FLOWLINE FROM SINGUE B, IN THE SINGUE BLOCK, FOR THE SECOND EXPANSION OF THE SINGUE B PAD, DRILLING OF 20 WELLS, CONSTRUCTION OF THE ACCESS ROAD AND INSTALLATION OF THE FLOWLINE, located in the province of Sucumbios, which must strictly be complied with. On the contrary, the Environmental License will be suspended or revoked, according to what is established in Article 281 and 282 of Ministerial Agreement 061, published in the Special Edition of Official Gazette No. 316, dated May 4, 2015.

This Environmental License is governed by the provisions of the Environmental Management Law, the Unified Text of Secondary Legislation of the Ministry of the Environment, and by the Legal Administrative Regimen Statute of the Executive Branch.

The Under Secretariat of Environmental Quality and the Provincial Office of the Ministry of the Environment in Sucumbios are responsible for ensuring application of this Resolution.

The Legal Representative of GENTE OIL ECUADOR PTE. LTD. is hereby notified of this Resolution, and it is thus published in the Official Gazette as it is of public interest.

The Environmental License shall be recorded in the National Index and License Registry.
